2.0 **PRE - QUALIFICATION REQUIREMENTS (PQR) :**

- 2.1 a) The bidder should have carried out technical evaluation of UCG suitability of coal or lignite block.
- b) They should have installed, tested and commissioned one number of pilot UCG Plant minimum Syn-gas production capacity of 120000 Nm<sup>3</sup>/ per day and the plant should be in successful operation for minimum period of 100 days during the last 5 years.
- 2.2 A bidder who does not meet the above qualifying requirement, can also participate if he can furnish satisfactory evidence that he has a valid collaboration agreement with collaborator(s) so as to fully meet the qualifying requirement {singly or jointly i.e. the collaborator(s) by themselves or along with the bidder) stipulated as in clause - 2.1 above provided the bidder shall furnish an undertaking jointly executed by him and his collaborator(s) to guarantee the standards of performance of the UCG plant. In the case of bidders participating with a collaboration agreement as above, such agreement shall be in force and shall be further valid at least up to the completion of the proposed contract.
- 2.3 The bidder who does not meet the above qualifying requirement, can also participate along with an associate, if the associate is the Parent/Principal/ group company of the bidder (who fully meets the qualifying requirements singly or jointly i.e. the associate by themselves or along with the bidder, stipulated as in clause-2.1 as above). However, in such cases, the bidder and his associate shall furnish a joint deed of undertaking to guarantee for the standards of performance of the equipment as detailed in the tender specification.

- 2.4 The successful bidder meeting the qualifying requirements with Collaborator/associate as the case may be, shall furnish a Contract Performance Guarantee in the form of an on demand Bank Guarantee for the faithful performance of the Contract for a value of 10% of the total contract price after the award of LOA. In addition, the Collaborator(s)/ associate shall each furnish a backup Bank Guarantee for 5% of the respective portion of work.
- 2.5 Average annual turnover of the bidder, combined average annual turnover of their collaborator(s)/ associate/ consortium member(s) as the case may be in the preceding three consecutive financial years as on the original scheduled date of tender opening, shall not be less than Rs.36 Crores. The bidder and their collaborator(s)/ associate should have positive networth as per latest audited financial statements. Copy of audited annual financial reports/balance sheets certified by chartered accountant for the period indicated above shall be produced.
- 3.0 **OTHER CONDITIONS:**
- 3.1 Bids which are submitted without proper documentary evidence to substantiate fulfillment of the qualifying requirements as specified, are likely to be rejected without assigning any reasons.
- 3.2 Notwithstanding anything stated above, the purchaser reserves the right to assess the bidder's capacity and capability to perform the contract, should the circumstances warrant such an assessment in the overall interest of the purchaser.
- 4.0 **BRIEF SCOPE OF WORK:**
- The scope of work includes to take up technical feasibility study and Underground Coal Gasification Pilot Project in UCG lignite blocks viz. Dipside Tadkeshwar & Dungra and Dipside of Valia & Rajpardi lignite blocks in Gujarat. This Scope of Work is indicative only. Detailed Scope of Work is contained in Technical specification.

The copies of necessary certificates duly attested by any Notary Public (or) Gazetted Officers (or) practicing Chartered Accountant with seal and date shall only be accepted and enclosed along with bid in Part-I cover, failing which the bid shall be summarily rejected.

In case of Indian bidders which are registered with NSIC/covered under MSMED Act, 2006 /MSME are exempted from furnishing Bid Guarantee provided that such Micro and small scale units are registered under single point registration scheme of NSIC/ covered under MSMED Act,2006/MSME and the same is valid on the scheduled date of tender opening and the product range mentioned in the certificate is the same or similar to NLCIL's requirements.
