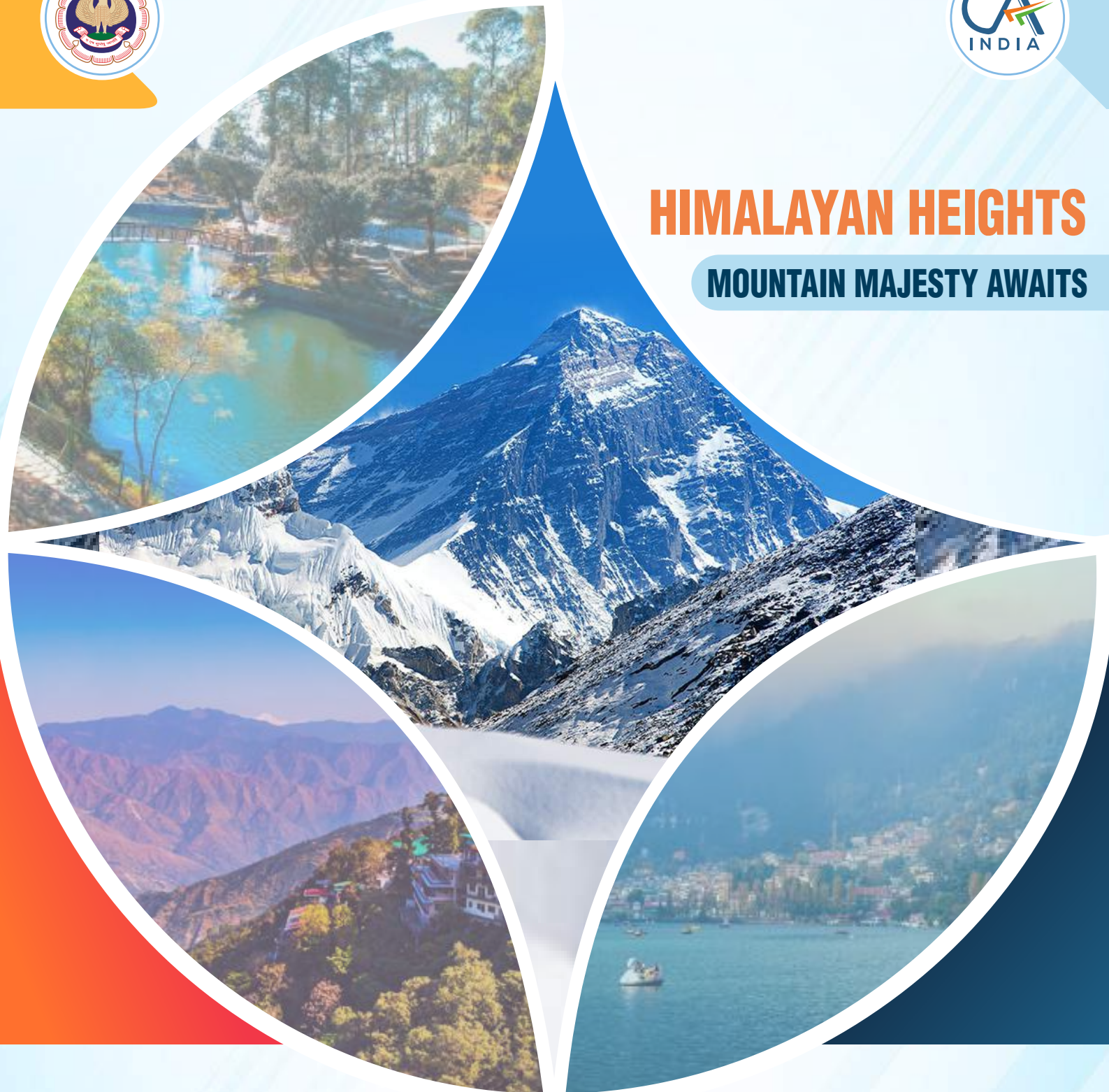

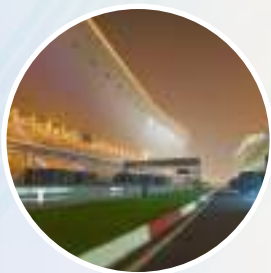

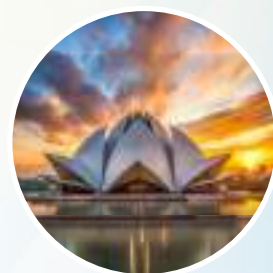


India Gate

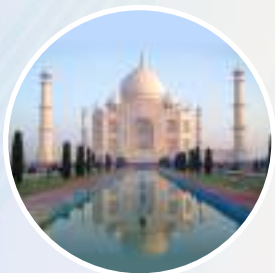
Akshardham Temple

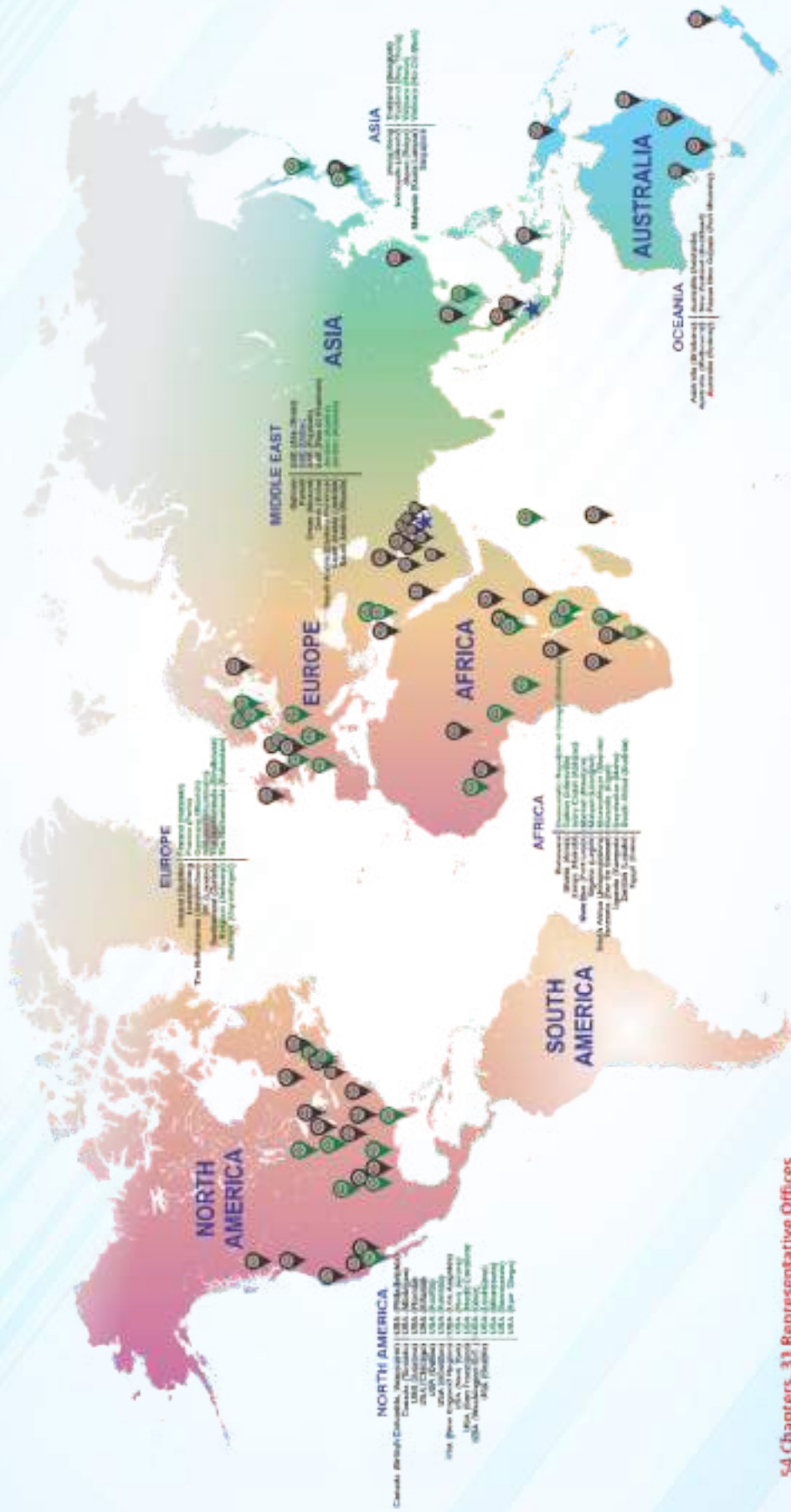
