The sealed envelope should be submitted to the attention of the Head of Chancery, Embassy of India, Moscow latest by 26.11.2018 accompanied with the proof of payment of Rbls. 25,000/- to the Embassy of India, Moscow vide bank transfer (Bank details can be obtained from the Embassy while visiting the site for inspection). The amount of Rbls. 25,000/- will be treated as earnest money deposit/bid security and would be returned to all the unsuccessful bidders within 30 days after finalization of the contract with the successful bidder.
- 6. The successful bidder shall be obliged to deposit an amount equivalent to 5% of the value of the contract to be awarded as performance security.
