- (a) The envelope should contain the total cost of work along with detailed breakup of costs.
- (b) It may be noted that the quotation should be valid for a period of six months.
- 7. Sealed envelope should be submitted to the attention of the Head of Chancery, Embassy of India, Moscow latest by 12/02/2016 accompanied with the proof of payment of Rbls. 30,000/- to the Embassy of India, Moscow vide bank transfer (Bank details can be

obtained from the Embassy while visiting the site for inspection). The amount of Rbls.30,000/-will be treated as earnest money and would be returned to all the unsuccessful bidders within 3 working days of the opening of the bid.

8. Representatives of all the bidding parties can be present at the time of the opening of the bids.
