**Notice Inviting Bids**

The Embassy of India, Moscow invites bids/offers from interested firms/contractors for carrying out repair and painting works at its building at Vorontsovo Pole 9, building No.2 Moscow, 105062.

2. **Scope of Works:**

- i. Repair and plaster of facade of JNCC building
- ii. Whitewashing of the building from outside
- iii. Repair of leaking of the roof where it is require
- iv. Cleaning/white painting of iron grills of the windows
- v. Asphalt of door/premises in front of the building
- vi. Replacement of plastic roof on entrance of basement way of JNCC
- vii. Making the garbage place with roof/wall (plastic) to look decent
- viii. Repair/replacement of tiles of toilet room at 1<sup>st</sup> floor

3. **Payment Schedule:**

50% payment of the total value of work is to be paid before commencement of the work. Remaining 50% payment will be made on completion of the work to the satisfaction of the Embassy of India. Any delay in the completion of work beyond the agreed duration would lead to deduction in payment @ 0.5% of total value of contract per day of delay subject to a maximum of 10% of contract value.

4. **Site Visit:**

Interested parties may visit the site from 24.05.2023 to 14.06.2023 for taking measurements to identify the scope of work and for formulating their quotations. A prior appointment should be made with Establishment/Property Section of the Embassy of India, Moscow (Mr. Rakesh Kumar, Tel. No. +7 9991 184 42 83, Mr. Tribhuwan Yadav +7 926 234 21 52) for this purpose. The detailed proposal should also outline the timeliness required for the project.

5. **Submission of Bids:**

Companies are required to submit their offers/bids in a sealed envelope superscribed "**Repair and painting works in Embassy of India buildings at Vorontsovo Pole 9 building No.2, Moscow**", describing in detail the breakup of the required works along with the cost of each component. The bids/offers should be valid for a period of three months from the date of opening of bids. The sealed envelope containing the bids/offers should be addressed to **Mr. Naorem J. Singh, Head of Chancery, Embassy of India, Vorontsove Pole 6-8, Moscow, 105 064** so as to reach the Embassy latest by **14 June, 2023 (by 1700 hrs)**.

6. Opening of Bids:

The bids shall be opened on **15 June, 2023 at 1600 hrs at the Embassy of India, Vorontsovo Pole 6-8, Moscow**. Representatives of all the bidding parties can be present at the time of the opening of the bids. The work shall be offered to the lowest bidding party by means of a contract, which will be signed with them.

7. Completion of Work:


The work should be finished within a period of 20 days after the signing of the contract and guarantee of work should be valid for 2 years from the date of completion of the work. Any delays that arise during the course of the work must be discussed with the Embassy of India immediately and agreed to. The Contractor shall be held responsible for any delay in completion of the work beyond the date mutually agreed upon. If the Contractor fails to complete the work within the agreed time, Liquidated Damages for delay in execution of the work attributable to the Contractor shall be deducted from the Contractor @ 0.5% of contract value per day subject to a maximum of 10% of contract value. Any defect that develops during the guarantee period shall be addressed by the contractor at no extra cost to the Embassy of India.
