- Scraping of old paints from walls and ceiling, leveling with cement smoothening of surface i)
- Repair wherever needed and painting of walls and ceiling of approx area of 410 square meters.

- Companies are required to submit their bids in a sealed envelope (Title: Repair of staircase located at 10/2, Bolshaya Dorogomilovskaya) describing in detail the breakup of the required work along with the cost of each component. The bids should be valid for a period of three months from the date of the opening of bids.

The sealed envelope should be submitted to the attention of the Head of Chancery, Embassy of India School, Moscow latest by 2.00 pm on 06.04.2022 accompanied with the proof of payment of Rbls. 25000/- to the Embassy of India School, Moscow vide bank transfer (Bank details can be obtained from the School Office while visiting the site for inspection). The amount of Rbls. 25000/- will be treated as earnest money deposit/bid security and would be returned to all the unsuccessful bidders within 30 days after finalization of the contract with the successful supplier.
- The successful bidder shall be obliged to deposit an amount equivalent to 5% of the value of the contract to be awarded as performance security.
