Notice Inviting Bids**

The Embassy of India, Moscow invites bids from interested contractors for the following work REPAIR OF STAIRCASE in our School located in 10/2 Bolshaya Dorogomilovskaya (5 floors) as per the following specifications:-

- i) Scraping of old paints from walls and ceiling, leveling with cement smoothening of surface area.
- ii) Repair wherever needed and painting of walls and ceiling of approx area of 410 square meters.
- iii) Purchasing and fixing of new tiles.
- iv) Replacement of 48 meters wooden rails.
- v) Painting of glass paints on doors, windows and batteries from 1st floor to 5th floor.

Note: The work should be finished within a period of 20 days after the signing of the contract and guarantee of work should be valid for 3 year from the date of completion of the work.

2. The schedule of payment for the work will be done in the following manner:
 - (a) Mobilization advance of 30% of the total value to be paid within 3 days of the signing of the contract. The contractor will be required to furnish bank guarantee for the same amount.
 - (b) Final payment of 70% of the total value of the work to be paid on completion of the work to the satisfaction of the Embassy of India.
 - (c) Any delay in the completion of work beyond the agreed duration would lead to deduction in payment @ 1% of total value of contract per day of delay.
3. Interested parties may visit the site and ascertain the scope of work for formulating their quotation from 17.05.2022 to 20.05.2022. A prior appointment should be made with Office of the Embassy of India School (Tel.No. 499 2437009) for this purpose.
4. Companies are required to submit their bids in a sealed envelope (**Title: Repair of staircase located at 10/2, Bolshaya Dorogomilovskaya**) describing in detail the breakup of the required work along with the cost of each component. The bids should be valid for a period of three months from the date of the opening of bids.
5. The sealed envelope should be submitted to the attention of the Principal, Embassy of India School, Moscow latest by 2.00 pm on 31.05.2022 accompanied with the proof of payment of Rbls. 25000/- to the Embassy of India School, Moscow vide bank transfer (Bank details can be obtained from the School Office while visiting the site for inspection). The amount of Rbls. 25000/- will be treated as earnest money deposit/bid security and would be returned to all the unsuccessful bidders within 30 days after finalization of the contract with the successful supplier.
6. The successful bidder shall be obliged to deposit an amount equivalent to 5% of the value of the contract to be awarded as performance security. The performance security shall remain valid for a period of 60 days beyond the completion of all contractual obligations of the supplier. The bid security shall be refunded to the successful bidder on the receipt of the performance security.
7. Representatives of all the bidding parties can be present at the time of the opening of the bids. The bids shall be opened on 01.06.2022 at 12:00 noon at the Embassy of India, Moscow, Vorontsovo Pole, 6-8. The work shall be offered to the lowest bidding party.
